## Mike Yee, Biologist, MVC

- Presentation: “Lanark Highlands Water Forum 2005 Lake Stewardship”
- Watershed Watch program. State of the Lake Report
  - Water Quality Concerns; why so many weeds, is something we are always concerned about. The watershed Watch Program objective is to accumulate reliable environmental data to determine the limits to which lakes can handle nutrient input. The information is used to encourage lake property owners and users to help restore Lake Habitat and adopt good stewardship practices. Many lakes were sampled in 2003. Dalhousie Lake is scheduled for sampling in 2006.
  - Phosphorus is a driver for land. For water, phosphorus is not as desirable. If we want to limit weeds, we can do this by limiting the amount of phosphorus going into our lakes. This can be achieved by;
    - Build at least 30 metres ways form the shoreline
    - keep your lot well treed
    - Pump out your septic tank every 3 to 4 years,
    - Reduce water use and use phosphorus free detergents
    - Keep the size of your lawn to a minimum
    - Do not use fertilizers, herbicides or pesticides.
- In essence if we remove the natural vegetation from shorelines, we are ultimately taking away the quality of our lake. What we do on land greatly impacts our lake.
- Monitoring Programs; Frog Watch and Ice Watch are some of the programs that could assist us in monitoring our lakes.
- 2001 State of the Lake Report: phosphorus was found to be extremely high. Dalhousie Lake is a sand plate and so there may be a possibility that this is contributing to the high levels of phosphorus? Our Lake is proven to be a very productive lake, meaning we should be more aware and conscious of what is going into our lake.
- Dalhousie Lake has some enrichment. It is in our best interest to follow best management practices on our properties to maintain the overall quality of our lake.
- Shoreline Cleanup; its ok to clean shorelines for such things as washed up weeds, pollen, etc. It's the removal of shoreline vegetation that is risky and not in our best interest.
- Weeds – are not necessarily a bad thing. Our lake does need this productive vegetative food source for the insects and fish of the lake. A lot of us aren't so content with them and so we tend to eliminate them. Mike recommended that perhaps we only clear a path or small area vs clearing the whole shoreline around your property. This way we win and so does the lake.
- Leeches – Our lakes habitat promotes leeches
- Zebra Mussels are an invasive species derived from the Great Lakes. When they get into our lakes, there isn't any other species to eat them. In 2001, zebra mussels were detected however; no adults were found, only larvae. For whatever reason, they haven't developed. The lake will be tested again in 2006.
- The lake association has posted reminder signs at boat launches around the lake to assist with reminding boaters to clean boats before entering into our lake.

### **Amendment of Constitution**

- Jim Christini read the existing constitution which was amended in 1998. The concern back in 1998 was the continued lack of representation of some zones around the lake. In 1998 motion moved by Jim Christini and second by Ray Doiron that the Dalhousie Lake Association Inc Constitution and Bylaws be amended to permit the expansion of directorship to a maximum number of 7; said directorship to be formed by interested association members owning property anywhere on the lake, as opposed to owning within a specific zone.
- Ron Jones read the new (2005) proposed amendment;
  - “For the purpose of electing Directors, the lakeshore and adjoining lands have been divided into six zones as set forth in Appendix A. Said directorship to be formed by interested Lake Association members owning property on the lake to a maximum of 7. One Director shall be elected from each zone plus one Director at large. When it is not possible to obtain a Director from each zone, a Director may be chosen from another zone. In any event, no one zone may have more than two Directors.
- Motion moved by Bob Spratt
- Motion Second by Russ Burns
- Motion unanimously carried.

### **Bulletin Board**

- Not everyone has internet and so the association is proceeding to build a bulletin board which will be erected at the site of Sylvania Lodge.
- The bulletin board will be used for posting advisories, meeting agendas, etc.
